### Appendix C – St Andrews Boundary

Following the Craigtoun Park Working Group meeting K Roberts discussed the confusion regarding the boundary line between St Andrews CC and Cameron CC with members of Cameron CC

Cameron representatives explain that when they were setting up the Cameron CC web site they requested an electronic copy of a map showing the boundary of the Community Council from Fife Council.

They were surprised to find that the map provided differed from the hard copy maps in their possession. It is not clear how or when the change of boundary line occurred. Enquiries with Fife Council have so far failed to explain how the confusion arose.

Cameron CC are convinced that the electronic map is incorrect and the boundary line shown on their hard copy map is correct. Having said that, if the boundary has been changed then Cameron CC would like answers to the following questions. When was it changed, Why was it changed and who authorized the change.

K Roberts offered to make more enquiries to see if St Andrews Community Council holds maps showing the boundary with Cameron CC and St Andrews CC.
